Secretary Book Guidelines

- Clubs must complete a physical Secretary Book. No electronic copies will be accepted!
 Clubs may complete (pdf) forms on the computer for neatness but must be printed and placed in the binder.
- 2. Secretary Books must be placed in a three-ring binder.
- 3. The Secretary Book must be organized using the following steps (steps a. through h.3) and placed in a three-ring binder.
 - a. Front cover must include:
 - i. Club name
 - ii. Secretary's name
 - iii. Secretary's age as of January 1 of the current year
 - iv. Current year
 - b. Complete the List of Advisors and Officers form.
 - c. Complete the List of Committees form.
 - d. Complete the Youth Membership Form or print the Club Roster from 4HOnline.
 - e. Complete the Club Roll. This form is used to record member attendance at club meetings. Make copies as needed.
 - f. A club program containing yearly schedule of meetings and other club information.
 - g. Include a **copy** of the club's Ohio 4-H Youth Development Club Constitution and Club By-Laws with signatures. *Note:* The originals are due to the Extension office by the April enrollment deadline.
 - h. Separate months with monthly tabs.
 - i. Each month should include:
 - 1. Meeting minutes (handwritten or typed)
 - 2. 4-H Club Meeting Worksheet (make copies as needed) or agenda with notes
 - 3. Copy of Treasurer's Report
- 4. To finalize the club's year, this book needs to be turned in on or before the Friday before Martin Luther King, Jr. Day in January.
- 5. The binder needs to be neat, complete, and organized with all required forms to be considered for the Outstanding Secretary's Book Award. Due to the increasing number of excellent secretary's books being turned in, it has become especially important for these guidelines to be followed <u>precisely</u>.
